THESE GOWNS PROVIDE FUN, FUNCTIONAL AND COMFORTABLE GOWNS TO HOSPITALIZED CHILDREN. IN ITS FIRST YEAR, OVER 141,000 GOWNS WERE PROVIDED TO STARLIGHT'S HOSPITAL PARTNERS ACROSS THE UNITED STATES. THE GOWNS ARE DESIGNED TO BE MORE FAR MORE COMFORTABLE THAN THE BASIC HOSPITAL GOWN AND ARE DESIGNED WITH ICONIC CHILDREN'S MOVIE AND VIDEO GAME CHARACTERS AND OTHER FUN AND COLORFUL DESIGNS.

STARLIGHT FUN CENTERS: FOR ALMOST 25 YEARS, STARLIGHT HAS DISTRIBUTED MOBILE ENTERTAINMENT UNITS WHICH CAN ROLL VIRTUALLY ANYWHERE IN A HOSPITAL, INCLUDING UP TO A BEDSIDE OR AN INFUSION CHAIR. THE STARLIGHT FUN CENTERS ARE SPECIALLY MANUFACTURED BY NINTENDO AND ARE UNIQUE TO STARLIGHT. THEY ARE VERY POPULAR WITH HOSPITALIZED KIDS AND PROVIDE ENDLESS HOURS OF ENTERTAINMENT AND DISTRACTION IN THE HOSPITAL. IN 2017, 381 STARLIGHT FUN CENTERS WERE DISTRIBUTED TO OUR HOSPITAL PARTNERS IN THE US.
